CONSTITUTIONAL DOCUMENTS

We can help set you up with the correct documents if you do not have a constitution. Establishment fees for a new ministry Constitutional Document include By-laws (addressing Congregational Membership and the Privacy Act 2000 requirements), Registration with ASIC and the completion of the ABN registration form, ready for lodgement to be recorded on the ABN Register after specific compliance details have been included on the form by the Company Secretary.

There are two ways to document a ministry by using the Special Purpose Company Limited by Guarantee process, and this is reflected in how the name is recorded:

Standard type: Faith Works International Ltd

Or as an Association. This one is limited by the State in which your ministry is located.

Costing:

a) Preparation and submission of documentation \$2100.00

Registration fees \$ 597.00

Total \$2,697.00

b) Preparation of all documentation to become a DGR (Deductible Gift Recipient)

Total \$1,900.00

Other information;

- a) The supplied Constitution has the essential Faith Works International Ltd. approved objects; we suggest you amend these clauses to suit your specific organisational preferences.
- b) This Constitution template includes the Faith Works International Ltd Statement or Tenets of Faith.
- c) Complete the information detailing 'Company Foundation Members and Directors.'
- d) The minimum number of Company Members is five (5), but if possible, use more, say up to ten (10).
- e) The minimum number of directors for <u>ATO compliance is three (3)</u>; however, we suggest you have a minimum of five (5), and they are chosen from the Company membership (refer [d] above). One of the directors shall become the company secretary.

The other very important matter is that the board MUST not be family-controlled.
